

**SHILOH CHRISTIAN CAMPGROUND
SWIM / BOATING CONSENT FORM
May 1-Sept 15, 2024**

The swimming facilities at Shiloh Christian Family Campground are not supervised by a lifeguard or other responsible person. In place of on-site supervision, this facility has established a series of safeguards to be followed by all guests.

We are required to notify you of these rules to ensure that water rescue equipment is at the beachside and that the swimming area is maintained in a sanitary manner. In the interest of your safety and that of your guests, we require you to follow these rules.

Please read the safety rules located at the swim area and outlined in this brochure. If you have any questions, we will be happy to discuss them with you.

Injuries can be prevented, and safety is everyone's responsibility. If you notice any problems with the water quality or the absence of safety equipment, please notify us at once.

Any child 16 and under must have this form filled out by a parent or guardian to swim at Shiloh.

ANY watercraft, Shiloh's or otherwise, must stay at least 50 ft away from Shiloh's docks and swim area once launched. No swimming is allowed off of Shiloh watercraft.

- **NEVER SWIM ALONE. A minimum of two adults 18 years of age or older,** must be present whenever this swimming facility is in use, with at least one adult on the beachfront.
- **THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION. Children under 16 years of age must be accompanied to the bathing facility by a parent or guardian,** or similar adult responsible for their safety and behavior.
- **IN AN EMERGENCY, NOTIFY THE FACILITY OPERATOR AND CONTACT HELP IMMEDIATELY.** Telephone numbers for the nearest emergency medical services are posted.
- **IF ANYONE HAS AN EPILEPTIC SEIZURE** they are not allowed back in the water for 24 hours.
- Only use this facility during posted hours of operation and swim only in the designated bathing area. Only swim within the swim lines.
- Alcohol is not permitted.
- **Females are asked to wear one-piece swimsuits (*MANDATORY*)**
- **Life jackets must be worn on all Shiloh watercraft.**
- **Only guests of this facility who have read and signed this form may use the waterfront.**

I have read and understand the bathing safety rules at this facility. I understand there will be no lifeguard on duty at this facility. I will abide by the rules listed in this brochure.

We also agree to hold Shiloh Christian Family Campground, it's officers, directors & assigns, harmless from and against any and all claims, suits, liens, judgments, damages, losses and expenses including reasonable legal fees and costs arising in whole or in part and in any manner in connection with any illness, injury or death from swimming or boating.

The undersigned is signing for all his/her guest/family staying or visiting at their site on Shiloh property and is responsible for informing them of all rules and regulations.
